Robert Anderson is both National Chairman from New Mexico and Chairman and Chief Executive of Atlantic Richfield Company.

Mr. Dent informs me that:

1. Anderson is reached in New York more often than Philadelphia.

2. The President ought to be reminded of the conversation he had with Secretary Hickel regarding the Senate seat of Clinton Anderson of New Mexico and the possibility of Robert Anderson being appointed to this seat. Dent states that since that time, Hickel has talked to Robert Anderson and indicates that Mr. Anderson expects the switch to take place in April or May.

This points up a need that these phone calls be staffed through all proper channels, a point I have already discussed with Steve Bull. He indicates that where possible all the phone calls will be staffed.

<u>Recommendation</u>: Under the circumstances this phone call should be sent to Dent for appropriate staffing.
