

Women's Rights

Scope and Content Note

The Nixon Library has compiled the following list of materials pertaining to women's rights issues during the Nixon Administration.

In the 1960's and 70's the emergence of the second wave feminism and the women's liberation movement broadened the scope of women's issues. While President Nixon took office in the midst of this 'new consciousness,' the Administration responded to the struggle for women's equality. The Nixon Administration was among the first to identify the burgeoning role of women within the government, the labor-force and the electorate.

During a press conference in 1969, presswoman Vera Glaser questioned the President's commitment to gender equity noting the administration's lack of women appointees. In the fall of 1969, President Nixon responded by creating the White House Task Force on Women's Rights and Responsibilities. Ms. Glaser was included as one of its members. By the end of 1969, the Task force published a report entitled, "A Matter of Simple Justice" issuing recommendations in order to achieve a more equitable ratio of men to women in the Federal Government.

By December of 1970 the president approved an action memo implementing several of these recommendations, and on April 21, 1971, President Nixon publicly announced a three-pronged initiative to increase women's role in the Federal Government. First, he issued a Departmental Directive requesting each Cabinet Secretary and agency head create an action plan for hiring and advancing women in their department. Second, Barbara Hackman Franklin was hired as a Staff Assistant to the President in the White House Personnel Office building a talent bank of women, monitoring the progress of departmental action plans and recruiting highly qualified women to policy-making jobs. Third, Jayne Baker Spain was appointed to oversee the advancement of women in the career civil service as Vice Chairman of the Civil Service Commission.

As a result of these proposals, several appointments were made incorporating qualified women in Federal Government. These strides include Dr. Dixy Lee Ray to the Atomic Energy Commission, Catherine Bendell as the Tariff Commissions Chairman and the hiring of the first female Federal Bureau of Investigation agents. Franklin's reports indicate the amount of women appointments quadrupled between 1971 and 1974. Another key appointment was Anne Armstrong, Counselor to the President and the first head of the Office of Women's Programs. Members of her staff included Jill Ruckelshaus, a member of the National Women's Political Caucus, Vera Hirschberg, Director of the Office of Women's Programs, staff Assistants Dr. Jean Spencer and Patricia Lindh acting as Administration liaisons for women's issues.

Women's rights matters also arose in the legislative and judicial branches, requiring executive response. After campaigning in 1968 as a supporter of the Equal Rights Amendment, the President continued his endorsement following its Congressional approval in 1972. With four Supreme Court seats open during the course of this Administration, there was a desire to see a female appointment named. In October, 1971 the President released the name of Sylvia Bacon among the list of potential candidates to Justice Hugo Black's seat on the court. The following January, President Nixon recommended Congress expand jurisdiction of the Commission on Civil Rights to bring sex discrimination suits under Title VII of the Civil Rights Act. Later, in March, President Nixon signed the Equal Employment Opportunity Act providing the Civil Service Commission with authority to

monitor affirmative action plans for the placement of women. Under the Administration, the Office of Consumer affairs began a program insuring non-discriminatory credit practices. Similarly, on June 23, President Nixon signed the Title IX portion of the Education Amendments of 1972. Reproductive rights were also an issue within the Administration, specifically regarding the Department of Defense's position on abortion in military medical facilities. While President Nixon did not publicly comment on the landmark case of *Roe v. Wade*, it was a topic heavily discussed and debated within the Administration.

The resources compiled below exhibit to what extent the administration's actions use the concentrated power of the presidency to push forth opportunity for women.

The Staff Member and Office Files of John Ehrlichman, within the White House Special Files Collection, reflect his duties as Assistant to the President in Domestic Affairs. These texts primarily reveal how women's rights issues were incorporated into the 1972 Republican Campaign Platform and the 1972 election. Other materials include drafts of President Nixon's State of the Union addresses and the inclusion of women's rights matters in those speeches.

The White House Special Files Subject Files listed in this finding aid belong to the Confidential Files segment. Among the Federal Government files, the search for a new Director of the Women's Bureau in the Department of Labor is discussed. This portion of the Special Files Subject Files also presents information regarding the circumstances of Patricia Hitt's retirement and the status of the Equal Opportunity Employment Commission. The Human Rights files include reports on equal opportunity employment within the Federal Government and the search for women appointments. Memos regarding the Equal Rights Amendment can also be found here.

Within the Subject Files of the White House Central Files, the Federal Government Organizations subcategories include Department of Labor, Department of Health Education and Welfare, Legislation and Women's Rights. The Department of Labor and Women's Bureau categories primarily involve sex discrimination cases, the reorganization of the Women's Bureau as well as the appointment of Carmen Maymi, successor to Elizabeth Koontz as Director of the Women's Bureau. Documents within the Department of Health, Education and Welfare cover a broader range of women's issues including the Equal Rights Amendment, abortion and Title IX. The Legislative boxes within the Federal Government organizations subcategory include testimony from Elizabeth Koontz on women's rights legislature and legislative scheduling. The Equal Employment Opportunity files mainly consist of sex discrimination cases investigations and the commission's search for women appointees. The Human Rights portion of the subject files included a section for women's rights covering many women's issues brought up during the Nixon Administration. The Welfare portion of the subject guide deals with family planning.

Among the White House Central Files Staff Member and Office Files, Anne Armstrong's series reflect her duties as head of the Office of Women's Programs. Robert Finch's files involve his responsibilities as Secretary of the Department of Health, Education and Welfare. Barbara Franklin's file group documents her work to recruit highly qualified women and her efforts to promote the Administration's policy on women. The office files of Allen C. Hall reflect the Administration's handling of public relations of women in the Nixon Administration.

The Audio Visual Materials incorporated into this finding aid include the White House Communications Agency Sound Recordings, the Main Audio File Collection, and the White House Tapes. Series B files of the WHCA Sound Recordings Collection recorded below consist of meetings

between women's organizations and Vice-President Spiro Agnew. The Series C files listed include remarks from Pat Nixon at meetings with women's groups, ceremonies honoring women appointees and the celebration of the 50th Anniversary of the Women's Bureau. White House Staff Member's recordings within Series H include press briefings on women's issues, remarks to audiences of women's organizations and interviews covering women's rights. The Series P, Formal Presidential Remarks, covers events honoring women and women's organizations, swearing in of female appointees, State of the Union addresses and the announcement of the 1970 Department of Health Education and Welfare appropriations veto denying subsidized childcare for working mothers.

Department of State Reports on women appointments and family planning are found within the Main Audio File portion of this finding aid.

The White House Tapes are divided into series based on where they were recorded. These audio tapes include recordings of the President and other members of the White House Staff. Topics covered include a range of women's issues including Administrative support of the Equal Rights Amendment, equal opportunity employment in the Federal Government, the 1972 Title XI Amendment to the High Education Act of 1965, the Roe v. Wade decision and the women's liberation movement.
