Transcript #1: Part of a conversation among President Nixon, John W. Dean, III, H. M. Exton, R. M. Glaser, Charles Southward, Walter E. Washington, and Jerry Wilson in the Oval Office between 10:05 am and 10:20 am on May 8, 1971.

Conversation No. 494-3#1

Washington: Reverend McIntyre, he's here.

President: Is he around?

Wilson: [Laughs]

President: What's he doing?

Washington: He's, uh, doin' a little marching.

President: What is, uh, it's not that [unintelligible] what, uh, does he have much of a crowd [unintelligible]?

Washington: The Chief was just saying he thought five thousand.

Wilson: That's what it is right now [unintelligible] headquarters. Five thousand.

President: Does he --

Wilson: [Unintelligible].

President: -- [unintelligible] does he have that many?

Wilson: Did he?

Washington: That's usually [unintelligible]

President: Yeah.

Washington: -- starts with that.

President: Right. Well, he doesn't bother 'em. He doesn't, uh --

Washington: No.

President: -- bother anybody, though, I don't think.

Washington: Oh no. He's caving in, uh. Governor Wallace 'n' Maddox 'n' --.

Wilson: [Unintelligible]. [Laughs]

President: Well, his read the key --

Wilson: The greatest [unintelligible].

President: Where're they meetin'?

Wilson: They're, they're startin' down at Fourth and Pennsylvania, march up the avenue 'n' come down behind [unintelligible].

President: Do they have a permit?

Wilson: Yes, sir. And they the greatest problem with them as always is jacking around these crowd estimates so he doesn't appear to have a low crowd.

President: Oh --

Wilson: [Laughs]

President: -- [unintelligible] he's, he's on the [unintelligible] area. Give 'em a little; it doesn't make any difference.

Wilson: Yes, sir. [Laughs]

Washington: Gets me mad when they say I wouldn't let them parade the same day as the, uh, Cherry Blossom Parade.

President: Is that right?

Washington: Yeah. Chief's all right now. They complimented the Chief this morning [unintelligible].

[Laughter]

President: Yeah, right, right. Well, I wanted to have you all come in to, for the purpose of, uh, of expressing my appreciation to each of you individually for your own leadership, but also to ask you to convey to the people -- many I've already talked to, the Mayor, the Chief, about this -- but the rest too [unintelligible] to convey to all the people in your own shops for the way that they handled it. This is a, this sort of thing -- I, I'm referring to the whole period here. It's a, it's one where it has to be a combination of firmness and restraint, and it's a delicate line. It's a very delicate line to follow, and, uh, it of course requires leadership at the top. It also requires rather remarkable poise by these people on your force, and the Armed Forces and the rest [unintelligible]. [Unintelligible] were rather provoked by people that are [unintelligible], you know, [unintelligible] these people that [unintelligible] and the rest of them just sit there and take it and handle it well but nobody was seriously injured. This is a very great, uh, [unintelligible] and Washington set an example here [unintelligible]. I was talking to the Attorney General yesterday, and he said, "[Unintelligible] all over the country." He said, "Well, this [unintelligible] Washington is setting an example. You know, maybe we can handle [unintelligible] problems in the same way." This isn't just the war [unintelligible]. I think there are always people going to raise hell about something. And it's a question of handling it well, and, uh, [unintelligible] Mayor, of course, uh, who is concerned as we all are about the fact that these people are [unintelligible] the tourist trade down to a minimum. And, uh, and I

think the feeling [unintelligible] now with Washington is that the city in which, uh, crime rate at least has been checked and somewhat receded, in fact. That's a very good thing to get out across the country, that this is a city that [unintelligible]. If they come, they want to protest, they can, but they're going to behave. If they don't behave, they're going to go to jail. That's all. [Unintelligible] and that's what I think is what you've gotten across very effectively. [Unintelligible] too you had a problem of, uh, what about the overtime? Did that --

President: -- [unintelligible] out. Are some of the fellows, uh, their overtime couldn't be paid [unintelligible].

Unknown: [Unintelligible].

Wilson: [Unintelligible]. We have some men who, uh, they can't pay. We pay no overtime, uh, above the rank of deputy chief, and so once the man hits the salary level above that of assistant chief, their overtime is stopped. They, they, they continue working, but they don't get paid.

President: I see.

Wilson: And, so, uh, I understand that Congressman Broyhill is going to introduce legislation to resolve the problem and --

President: Um-hum.

President: You had a lot of overtime, didn't you?

Wilson: Yes, sir.

Washington: Yes, we had, uh, we had about forty thousand hours on Monday and forty-one thousand hours on, uh, as far as we can check, uh, on Tuesday. Wednesday's figures are not all in. Uh, but it drops off after that with just, this is, this is as far as we can put together [unintelligible] --

President: Um-hum.

Washington: -- municipal services, Mr. President. This is a hundred thousand hours overtime just related to --

President: Um-hum.

Washington: -- to the demonstration.

Wilson: I would estimate two million dollars cost, uh, for the, you know, [unintelligible] --

President: Two million dollars.

Wilson: -- and then the [unintelligible].

President: [Unintelligible] they must be, be beginning to feel a little, uh, [unintelligible].

Washington: This is just overtime we're talking. The hours I was giving as just straight overtime is, uh, fantastic.

President: Have you got any estimate of what it costs for the whole thing, or you can't tell?

Wilson: The, the military costs must be phenomenal, our costs [unintelligible].

Unknown: I used [unintelligible] for anything so we would review that anyway. So theoretically, Mr. President, there's no official [unintelligible] DC National Guard.

President: Yeah.

Unknown: We got some [unintelligible].

President: The people here you knock over, you know, spread stuff in the streets.

Washington: I [unintelligible], Mr. President, this time is the nature of the situation, the disruptive character of the [unintelligible]. Oh, I know our citizens, particularly our businessmen, have called me have just, uh, well, one of them said, "Glorious." [Laughs] He's not given to that kind of language.

President: No.

Washington: But, uh --

President: But he was pleased --.

Washington: But he was pleased we didn't lose [unintelligible] and I think [unintelligible].

President: Didn't break any windows this time.

Washington: The windows, nobody was killed, no serious injuries.

President: That's important there, yeah.

Washington: And these are important things. The city moved, uh, pretty much with some inconvenience as it would although in the center of it you had, uh, disruption but the municipal services went ahead and [unintelligible]. [Laughs] People told me that sanitation services were better Monday [unintelligible]

President: Is that right?

Washington: -- in the outlying regions of the city but, uh, you know, it's something to think about and, uh, with, with the nature of this [unintelligible] fourteen thousand arrests, uh, disruption, and your city moves along. The only thing that they succeeded in doing was overcrowding the jails, and I, I don't know whether --

President: [Unintelligible].

Washington: -- [unintelligible] relates to --

President: Um-hum.

Washington: -- to Vietnam. [Laughs] I couldn't make that --.

Unknown: You know, one observation, sir, that, uh, I think is worth bringing up here, is the quality of soldier, because we brought soldiers in from all over the country, East Coast, and of course there were some from this local area --

President: How, uh, how many were in? How many were soldiers?

Unknown: Uh, ten thousand.

President: Ten thousand?

Unknown: Yes, sir.

President: And National Guard?

Unknown: I had nineteen hundred National Guardsmen, and, uh, I'm very proud of my men, Mr. President, because, uh, we're really closer to this group than the ac-, than the active forces. [Unintelligible] part-time soldiers.

the paratroopers from the Eighty-second Airborne who came up here to reinforce
the troops that normally are under General Glaser come up from nearby stations,
Fort Meade and Fort Belvoir.

Unknown: [Unintelligible] the soldiers I talked to before they left expressed a little
disappointment that they hadn't seen a demonstrator while they were up here.

President: Ha!

Unknown: Because they were guarding the bridges [unintelligible].

Washington: Mr. President, I want to, uh, play, uh, pay another special comment to, commendation, to all of the men in terms of how they worked to coordinate as fast and, uh, it seemed that [unintelligible] so, uh, well-planned, coordinated that, uh, [unintelligible] went along, I think, particularly Chief Wilson --

President: Um-hum.

Washington: -- is not only taking full responsibility for the tactical [unintelligible], but, uh, his performance in the field in my, in my opinion was magnificent.

President: [Unintelligible].

Wilson: [Unintelligible] had a lot of training, though, and their morale was high, yeah, it's been good for them. And --

President: Yeah, right.

President: Um-hum.

Unknown: I think, uh, if anything, I think the Tenth Marines from Lejeune and the Eighty-Second Airborne from, uh, Fort Bragg probably felt that, uh, that they could have done more, but, uh, they weren't used. They --.

President: Yeah.

Unknown: We in fact brought a few troops into town we didn't need, but on the other hand [unintelligible].

President: Sure, there was all the estimates you had, you had to, 'cause if the thing had gone, you know, they had a huge number. I think that the best stroke was the going in there Sunday morning. When you knocked those, when you got the hard core, then they couldn't get organized.

Washington: Yeah, they were all over the place.

Washington: They, they'd been sleeping with hardly any facilities, hardly any food, most of them just, uh, just what they put together, just pots of stuff they were boiling down there, beans and everything. We put them in an outside enclosure and --

Washington: -- which is really better than a cellblock. [Laughs]

Unknown: Did, did you see where one of them complained about getting a baloney sandwich because he was a vegetarian?

Washington: -- so I figured they were just [unintelligible].

President: Peanut butter and jelly. Oh, boy, I'm telling you.

Wilson: You've got a real sense of power, Mr. President, when you call up McDonald's and say I want five thousand Big Macs.

President: Well, d'you do that?

Wilson: Yes, sir.

Dean: A lot of street solicitation was going on.

Washington: A lawyer, he said he was. That he only had --

Washington: -- a couple thousand dollars and, uh --

President: Umm.

Washington: -- in the meantime the rest of 'em were in there and it did come up to about two hundred thousand. Fourteen thousand's a lot of bodies. [Unintelligible] I, uh, must admit, Mr. President, our crisis facilities are not prepared for, for that number, and I would hope to prepare them for that number.

It's a very difficult situation to put young policemen, soldiers, and the rest of 'em just sittin' there facing them [unintelligible] swearing at them, and so forth. Okay.

President: Uh, it's, uh, they swear at them, and so forth, what would you do? Stop to think. What would you do? If you're in the service and you see a bunch of guys that aren't in, you know, for the most part, you're probably a draftee or something and say, "What's the matter with that s-, s.o.b." Huh?

Unknown: The difference between the news reporting on TV film clips and what actually took places, you can hardly recognize the, what you're seeing on TV.

Unknown: Oh, no.

Unknown: There's another --.

Unknown: Completely out of context.

President: Yeah, of course, of course.

Wilson: [Unintelligible] the, the, the news photographers at the Vietnam Embassy Thursday told me that tomorrow they're going to announce a demonstration by the newsmen against any coverage of further demonstrations. [Unintelligible].

The second thing, I want to assure you that, that, uh, [unintelligible] the second-guessers and Monday-morning quarterbacks, you know, that as far as I'm concerned, we back you all the way and, uh, we're not going to take any of this jazz to the effect that we were [unintelligible] done this or that or the other thing. The, uh, the, uh, situation here was one that had a potential of violence and had the potential of stopping the Government. And, uh, [unintelligible] we had the responsibility to avoid violence and just keep the Government running. We did both. We're going to do it again. The other thing is that I want everybody put on notice that, that's one of the reasons I [unintelligible] 'cause I know they, they would like to see it brought to a halt [unintelligible]. As far as I'm concerned, they come to town again, they're gonna get it again. And I want that understood. They're gonna get it right again. That's the way to keep 'em out. When I say "they," anybody can come to this town; they can march peacefully; they can have a permit; they can go up and down; they can shout obscenities, anything like that, fine. But nobody can come to this city and break the law without being prosecuted. And I think that should be clearly understood. And if you go after 'em, you'll be backed, and we'll fight in the courts and every place else. The civil libertarians [unintelligible].
