Transcript #1: Part of a conversation between President Nixon, H. R. Haldeman, and Stephen B. Bull in the Oval Office between 12:03 pm and 12:09 pm on May 4, 1971.

Conversation No. 490-16#1

Haldeman: They've got a, uh, plan for the Federal Employees for Peace to have a, a meeting in the Lafayette Park tomorrow at noon. We're gon', we're --

President: Just a second. [To White House Operator] Colson, please.

Haldeman: Our, our thought is to go for, have Justice go for an injunction, which they think they can get, and turn it off. And it would seem like it's a good thing not to have happen, at this point, and let the attention focus on the de-. The other bad guys are gonna go on the Congress. Let 'em, let it focus on that.

President: How could Justice get an injunction?

Haldeman: I dunno. They seem to think they can just on the basis of all the problems around or somethin'. But, uh, TV would make a big thing outta, outta the Federal employees demonstrating against the Federal Government, which doesn't seem to have --.

President: What the hell is this? He's got somebody down in the road here [unintelligible] here. Those dirty punks! [Unintelligible]. Okay. There, he's presenting him with a, with a summons.

Haldeman: [Unintelligible] one there, didn't they?

President: No, [unintelligible]. Well, who the hell are they? They're a bunch of goddamn

State Department bastards that [unintelligible].

Haldeman: I think most, they're probably mostly HEW, HUD, 'n' OEO and, uh, [unintelligible]. I, I would bet there won't be any State Department people there. I think they got --

President: The word?

Haldeman: -- better sense. They got enough problems without --.

President: [Unintelligible] for Peace. Bunch o' bastards in the bureaucracy! Gotta remember --.

Haldeman: [Unintelligible] in the normal course it wouldn't make any difference if they --.

President: [Coughs]

Haldeman: The reason for not letting 'em do it is that TV will make such a big thing out of --.

President: Try to play it calmly. Fine-looking in a nice --.

Haldeman: Yeah.

President: Clean people.

Haldeman: Yeah.

President: [Unintelligible]. How will they enjoy them, on what grounds?

Haldeman: -- they have to move on some, some other grounds. But I think they've got, they've got a, doing it on the basis of the other activity here or somethin'.

President: The war will [unintelligible]. The little bastards'll be out on somethin' else.

Haldeman: [Unintelligible].

President: Yeah. Pot [unintelligible].

Haldeman: Federal Employees for Clean Air.

President: Why, they're the dirtiest damn people there are! They throw crap all over the place. Ragged, unkempt, as though the ecology of my time wasn't discovered, huh?

Conversation No. 490-16#2

President: How do your, how do all your operations looking, I mean, some other --

Colson: Well, I --

President: -- of Elliot's schemes?

Colson: -- I think well, Mr. President. We, uh, we'll have six Senators at the moment, possibly some more being added this afternoon, who will speak tomorrow on the, attacking Muskie and Humphrey, particularly, uh, [unintelligible] by name.

Haldeman: Really?

Colson: It took courage. We've sent them up speeches this morning. Scott's gonna join 'em. Taft [unintelligible].

President: On what ground did [unintelligible] attack 'em?

Colson: Well, two grounds. Muskie on his charges against the FBI for surveillance of --

President: Right.

Colson: -- Rennie Davis on Earth Day.

President: Right.

Colson: We're sure it comes back to haunt 'im.

Colson: Humphrey for, uh, condemning densities: demonstrations, lobbyists. [Unintelligible] has endorsed them and in fact encouraged them. Muskie obviously for his open endorsement of the May, for the April twenty-fourth demonstration, and his visiting the, uh, demonstrators on the Mall --

President: Yeah.

Colson: -- sending 'em oranges [unintelligible]. He sent 'em oranges today [unintelligible].

President: [Unintelligible].

Colson: I've heard that today.

President: And having somebody from California givin' 'em to 'em?

Haldeman: Ray Irwin's gonna. [Laughs]

Colson: [Unintelligible].

President: Hell of a lot of oranges. Uh, anyway, uh, what's Kennedy doing about all of this?

Colson: He's out of town, conveniently, and, uh, we've been trying to get his --.

Haldeman: -- he was with the veterans 'n' he quit them. You know, just incredible demagoguery! He put on that flight jacket with the Presidential seal on it to go down 'n' talk to the veterans.

Colson: He's, uh, he's playing it the smartest of all. He's had nothing to say about April twenty-fourth. He, uh, [unintelligible]. And now with Vietnam Veterans Against the War, 'n' he, uh, I found him yesterday in his office, would not comment. Reporters called four times yesterday and once again this morning and still didn't get a comment. He's not gonna get caught on this one.

- President: Tired of the whole bunch of 'em. Just say that, I mean, throw it around there that, uh, get, they gotta get the impression after all that they're they have condoned it, uh, permissiveness. I don't know; I --.
- Colson: Well, this is, this is really --.
- President: They, they've [unintelligible]. For Christ's sakes, if they could take us on for those silly damn Birchers, what'n the hell they gonna do with these people?
- Colson: That's right.
- President: These people are part of them. They come into their offices. They, they also've the same contributors.
- Colson: Well, this, this group that has caused the trouble this week was a co-sponsor of the April twenty-fourth show --

President: It has?

Colson: I think so, Mr. President. I think the, uh, scattering --

President: [Unintelligible].

Colson: -- of the people coming in and outta Washington is, showed that it doesn't take much to, uh, provoke once again the, uh --.

President: The social issue in terms they don't like -- kids with, uh, smokin' pot, [unintelligible], and raisin' hell --

Colson: Blocking traffic 'n' being [unintelligible] and, uh, vandals, destruction, destroying property. [Unintelligible] you never watch television, but if you --

President: No sir!

Colson: -- ever saw the last two minutes of NBC News last night, it, uh, gets 'em better than any Laurel and Hardy comedy that I've ever seen. Did you see the --?

Haldeman: Is that when he hit the guy in the face? John Ehrlichman told us the time.

Colson: Oh, yeah, they, uh, fella out in the street, gettin' out of his car, 'n' he was carrying his raincoat 'n' his umbrella 'n' he never let go of 'em, 'n' he kept goin' around, 'n' he'd pick up a trash can, and it was all, it was like a s-, old silent movie, except you could hear the trash cans. No voices, 'n' he'd, he'd move it out of the street, 'n' the demonstrators'd move it back, 'n' eventually the frustration got too much for him. He walked over the NBC cameraman 'n' just popped him in the nose, 'n' [laughs] all you could see was the camera [unintelligible] up in the air. [Laughs]

President: Good, good.

Colson: Total frustration had it. But what people saw when they saw that was just decent citizens who were pretty fed up with garbage being thrown in the streets --

President: Good.

Colson: -- out of cans.

President: Good, good.

Colson: I was amazed --.

President: I think one thing, of course, is that this gives a bad name to the whole demonstration.

Colson: Yes.

President: Nobody's gonna stop it, you know what I mean. They, it's the last act they remember. I, I, don't you think, Bob, that, uh, awful lot of people are gonna think who, he was in that demonstration in Washington. Who's gonna remember it was the twenty-fourth?

Haldeman: 'S gonna be a big blurb in the dissidence. Not only is it collapsing, but it's by far the most vivid. There's much more --

President: Action.

Colson: No.

Haldeman: -- impressionable type stuff on the, in this, last night=s --

President: Well, our guys don't --

Haldeman: -- [unintelligible] than last week.

President: -- our guys should play it just solely in terms of their hypocrisy: they endorsed the demonstrators. In other words, I would even try to say that they distinguished it. I wouldn't say they changed their minds. I would "Let it be noted that,≡ say, Athat the people that have endorsed, Humphrey has endorsed, Teddy Kennedy's endorsed." Him too.

Colson: Um-hum.

President: [Unintelligible]. Then let them deny it. The way to make the charge is to just charge that they endorsed demonstration, then let them deny. That's the way to do it.

Colson: Dole did that. He set the stage for that [unintelligible].

President: Did he?

Colson: Yeah, when he, he gave a speech, that was well reported, in which he said, "Let all of those who have called for these demonstrations and encouraged them, all Democratic Senators, come forward now and insist on the preservation of order in Washington." And he, he gave it a good broad brush that, uh, is what I'm sure caused Allen's, uh, disavowing against it. [Unintelligible] guess with the exception of the Kennedy --.

President: Of McGovern?

Colson: Bayh, Bayh, uh --

President: Well, hell --.

Colson: -- he didn't do anything. McGovern --.

President: Bayh probably deplored it. He didn't make any [unintelligible].

Colson: No, McGovern's denounced yesterday.

President: Huh?

Haldeman: One guy just keeps the drumbeat going.

Conversation No. 490-16#3

President: Let me say this. The other thing, the other thing is this: that, uh, this, this, the, the networks will quickly recover. They, uh, they must be dying, don't ya think?

Colson: I'm sure they hated to run that last night.

President: Sevareid and the rest, Jesus Christ, they must be dyin' o' [unintelligible]. But, uh, they're, uh, Chancellor now, he snarled around, "It's beautiful day, a beautiful day in the city." Bitch. But my point is that they had to run it, didn't they? Finally, finally had to run one.

Colson: That's right.

President: This really the first time they've run a nasty one. They didn't run anything on November fifteenth or October --.

Haldeman: It's the first time they've really run nasty stuff since Chicago.

President That's right. Completely nasty stuff.

Colson: And the point, and the point which Cronkite did not let people forget last night when he said, "This is not dissimilar from Chicago." [Unintelligible].

President: [Unintelligible] Police Board Executive Committee complaining about, uh, being [unintelligible] of the hippos.

Colson: I suspect there'll be more.

President: Is the position of the administration clear, that we're talkin= strong and firm?

Colson: And got on the networks and on the out-of-town papers. I had a few on my desk.

- Colson: Yeah.
- Haldeman: -- I guess. I've never even met the guy, but I --.
- President: Tries to charge up his troops.
- Haldeman: He wen-, yeah. And yesterday he was out, they made the point that he was out on the front lines at four o'clock yesterday morning, and he, he covered every trouble point. He was zooming all over the city --.
- Colson: In his motorcycle.
- Haldeman: He got o-out of his squad car [unintelligible].
- President: His motorcycle?
- Haldeman: He got out of his Chief's car and got in a side-sidecar of his escort's motorcycle. and had it whip around in and out of the cars 'n' stuff. He led the charge up the Hill to get a bunch of people 'n' --.

And [unintelligible] said to him, "Now, Chief, what d'ya gonna do for us?" And he said, "You got your own police force up here, unless you, unless you Senators feel we need some help." [Laughs]

Colson: [Unintelligible].

President: That's right. Put it right to the Senators.

Colson: Oh, [unintelligible].

President: They have, they've always been jealous of that stupid Capitol Police Force, and they oughta clean it up.

Haldeman: Well, his line yesterday showed great skill, y'know, when they said, "Well, don't you think you moved too hard and too fast on it?" And he said, "We'll let the American people be the judge of that."

Colson: And, uh, if it raises it, it raises it in a helpful way. The reason that the doves are saying what they are saying is because it's so. The, uh --.

Haldeman: Same effect as the November moratorium in sixty-nine.

Colson: Yeah.

President: You mean, it went too far, backfired.

Colson: [Unintelligible] really did. October --.

President: The October one, the October one particularly.

Colson: They're worried on the Hill that, uh, if they now start pressing for an immediate

President: What do you think of these people that have been raising hell? Did ya see any of that?

Woods: [Unintelligible]. Yeah. I was, comin' to work yesterday morning, a lot of 'em [unintelligible] the papers >n' everything [unintelligible] in front o' the car. I saw them push one Vokswagen bus about -- oh, eight or ten of them -- push it right into the side of a woman's car while we were sitting there [clears throat] held up in traffic. It was back in her lot, and they just pushed it right into the side of her, just rammed into the side of her car.

President: I think they hurt themselves with this.

Woods: Oh, they did, they did, because I think it was great when you saw citizens out pushing 'em around and --.

President: We got on the right side o' this. I called the Chief, 'n' they all reported, he reported to everybody that I called him and backed the Chief all the way. Got arres-arrested eight thousand of the damn people 'n' that's good, too. We wanna play a tough line with these people now [unintelligible].

Woods: The next thing this morning now they have a rally that they're gonna be telling all of them to, to no violence at all, you know.
