President: Well, you picked, picked most of the answers.

Buchanan: Well, it was a fine job [unintelligible]. [Laughs]

President: That, uh, that woman asked a silly question about Johnny Rhodes [unintelligible].

Buchanan: [Unintelligible] came off very well, though.

President: Oh, well, it was a good thing that the, uh, it showed that the poor guy, they're

givin' him a bad rap, ya know, and all that.
