Filed under the category FG (Federal Government-Organizations) are materials pertaining to matters such as establishment, disestablishment, organization, reorganization, audits, inspections, investigations, location, relocation, regulations, reports, appointments, and endorsements to top positions.

FG 6-20 pertain to the Council on International Economic Policy. The Council was created by the President's memorandum of January 19, 1971. The purposes of the Council were to achieve consistency between domestic and foreign economic policy, provide top level focus for the full range of international economic policy issues, deal with international economic policy, consider the international economic aspects of foreign policy issues and maintain close coordination with basic foreign policy objectives.

Among the principal correspondents in this subject category are the President, George Shultz, Peter G. Peterson, Peter M. Flanigan, William P. Rogers, Henry A. Kissinger, Richard V. Allen, Ken Cole, Deane R. Hinton, John Niehuss, John Ehrlichman, H. R. Haldeman, business executives, and Members of Congress.

Types of materials found here include memos, correspondence, press releases, clippings, schedules and schedule proposals, draft legislation, and clippings, primarily concerned with the establishment of the Council; staffing; scheduling; tariffs; Congressional relations; the General Agreement on Tariffs and Trade (GATT); shoe manufacturing; and the Council's annual report.
