

The Radio Television News Directors Association is made up of more than a thousand professionals whose purpose is to improve performance in all aspects of broadcast news.

They are the people—network news officers and news directors of the best station news operations in U. S., Canada and elsewhere—who find that this professional organization most effectively forwards their purpose: to provide the public with information and understanding to allow all citizens to take part effectively in an increasingly complex society.

Although established more than twenty-five years ago when public affairs was becoming an important matter for wider public understanding, the association has grown greatly and earned a position as accepted spokesman for the profession in recent years.

Supporting Activities-Annual Conference

The next Conference of RTNDA in Los Angeles will be the 22nd international session of newsmen to gather for a series of workshops and discussion sessions. The November meeting follows U. S. elections for which RTNDA members will provide hundreds of programs of discussion and interpretation as well as "hard news" campaign coverage.

Regional Seminars

The Association is also sponsor of a series of spring regional seminars held at five convenient locations spotted around the U. S. RTNDA thus brings to members a series of nationally-recognized speakers and allows members to seek general solutions to their common problems. All broadcast newsmen, members or not, are welcomed at these seminars as RTNDA expresses its interest in making more professional the work of every radio and television news and public affairs operation.

European Contacts

In the fall of 1967 members of RTNDA met with news directors of major European continental broadcasting stations and supervisors of European networks and program exchanges. The Association's general counsel, a noted Washington communications lawyer, instructed representatives of the European broadcasting union in American legal matters, and multi-language discussions, in simultaneous translation, were held to exchange ideas for better cooperation and mutual understanding between American and European newsmen.

Annual Awards

Among the most respected awards in news and public affairs broadcasting are the annual awards in three radio and television categories. One of the awards bears the name of Edward R. Murrow, longtime member of RTNDA, whose award honors the year's best work in documentaries.

The RTNDA awards are judged by professionals in the field chosen by major universities which supervise the judging. RTNDA is proud of the close relationships maintained with leading academic institutions and professionals as well as with working newsmen.

Conference on Editorials

The Association is one of the permanent sponsors of the National Broadcast Editorial Conference held each summer. The purpose of this Conference, as with others conducted by RTNDA, is to increase the public service qualities of the "product" aired for the public. The Editorial Conference is conducted for and by those who represent the best practice in properly researching and effectively airing editorial expressions of opinion—and those who wish to do increasingly good work.

■ Elected Spokesmen

The officers of RTNDA, those who speak for members at Congressional hearings and before other professional associations (such as bar associations), are all elected by the members. Directors for each region of the U.S. are elected by mail to allow every active member's expression of choice. Directors-at-large, the president and treasurer are elected at the Annual Conference.

These officers bring the weight of a national, recognized organization to bear when members seek assistance in legal matters, instances of needed opening of news sources and in providing information for appearances before private or public groups.

Every activity of the association is planned as a service to members of stations of every size.

■ The Code of Ethics

All members must subscribe to RTNDA's Code of Broadcast News Ethics. Copies appear on every application for membership blank. It requires members to act responsibly and professionally and pledges them to aid others, members or not, in achieving the Association's goals. A committee is appointed to act as "watchdog" in securing and maintaining code adherence.

■ The -RTNDA Bulletin .

The Association publishes the RTNDA BULLE-TIN magazine. It is supplied to members as part of the membership dues. (News directors pay \$30 for active membership, other newsmen and teachers \$6 for associate membership, persons in other professions or business may be privileged members at \$50.)

The BULLETIN contains texts of major addresses made to RTNDA Annual Conferences and Regional Seminars as well as at the Editorial Conference. It contains news notes of members and runs series of articles on such matters as mobile unit operation and newsroom design.

RTNDA has published a handbook on newsfilm shooting and a booklet on broadcast news careers. Three volumes on newsfilm standards, newscast construction and newsroom planning have resulted from Regional Seminar programs.

■ Committees

Many committees operate for RTNDA. Among the most important are the Freedom of Information Committee, assisting members in news access and the Placement Committee which offers immediate assistance, both to individuals seeking positions and employers needing qualified news personnel.

RTNDA Foundation

The RTNDA Foundation was established by funds of the association voted by members and other contributions of individuals, corporations and foundations in 1967. Its resources will shortly provide the first of annual scholarships for college and university students studying broadcast journalism. Awards will be made by a committee of the association and noted teachers in the field.

Canadian Members

Two Annual Conferences have been held in Canada, and as in the U. S., a series of Regional Seminars is held annually. They are located so that large numbers can attend and deal with important and timely broadcast news problems.



ABOUT THE RECIPIENT





MEMORANDUM FOR LOU NICHOLS:

As you know, the members of our industry are supporters of Dick Nixon in every way we can be helpful. Loren Berry, for instance, has given unstintingly of his time, money and effort to help Dick. Here is an eighty year old man who after a prostate operation sat up in bed on the third day and said, "I have to get up out of this bed so I can help Dick get elected President." And he did.

Another great helper is Paul Henson, President of United Utilities, and virtually his entire Board of Directors. Les Warner, the President of General Telephone and Electronics, which operates in thirty-four states, is another great Nixon supporter, as are all of his regional presidents. John Brown Cook, the President of Whitney-Blake and Reliable Electric, is another, and I could name several hundred more. But you know all of these people having broken bread with them so many times.

We are hopeful, and are working to the end that Dick Nixon will be our next President. In the interregnum between his election and inauguration, it so happens that the United States Independent Telephone Association will be holding its annual convention in Miami Beach (December 8-11). We already have a commitment from Senator Howard Baker to address our first General Session on Monday, December 9. On Wednesday, December 11, we will have our wind-up session in the Ballroom at the Fontainebleau, a place incidentally where Dick Nixon has spoken many times. The only person we have on the program that day is one of America's great professional speakers, Bill Gove - also a Nixon supporter.

We would hope that Dick would give consideration to appearing at the General Session on Wednesday, but if it is more convenient for him to appear at the General Session on Monday afternoon or at a luncheon we are having at the Convention Center on Tuesday, we would not care. We also recognize that he doesn't need to have any prepared speech to talk to us. He'd be amongst friends and supporters.

Loren Berry will be in residence in Miami Beach at that time at the Surf Club and if Dick didn't want to stay in a suite at the Fontainebleau we could arrange for him to stay either at the Surf Club or at the Bath Club. On the other hand, I know he has his own friends and facilities in Miami Beach and he might just be down there relaxing at this time anyway. If he wants us to arrange a deep sea fishing trip for him, John Brown Cook happens to have fishing boats at his disposal.

We realize, Lou, this is a long shot but we have great affection for the President elect and we would like to have him enlist us in his army of helpers - helpers he will need to carry on his program when elected.


