Dear Mr. Black:

I am writing you because once again we need your help for the Republican Party. Cap Weinberger, who as you know is now State Chairman, and I firmly believe that the election can be won if we make certain that the Republicans get to the polls and vote. This, as you will understand, is a mechanical job which takes a great deal of manpower. In 1956 we were successful in persuading many large businesses to permit some of their younger men to take time off to work for the Party. It is even more important that we get this type of cooperation in 1962.

If we could arrange to free between 25 and 50 men in the northern part of the State for approximately six weeks before the election, Cap and I are convinced that it would have an appreciable effect on the Republican vote. We realize that many businesses are sensitive on this score inasmuch as they will be accused of favoring the Republicans. We have no objection to extending similar privileges to the Democrats. Quite frankly, they would not use them as efficiently, nor would the added manpower do them as much good as it would us.

In setting up a program of this type it is essential to get started on the right foot. We would like you to issue an invitation to between ten to twenty selected top executives in San Francisco. Obviously we would want to consult with you and would rely on your judgment as to who should be invited. If we can get them together I am certain that Cap and I can convince them of the importance of what we are proposing and of the impact that it will have in November.

To use all the outside politicoes as suggested in the attached would, of course, be entirely contrary to our policy of running our own campaign in California, and should not be done.

The idea of messages from leaders of various segments of the community is excellent, as long as they are Californians. This should be followed up as to whether or not it is mechanically feasible. However, it should not be done by diverting the activity of campaign personnel. We will have to assume everyone at the Dinner is already for us, and our campaign efforts must be directed toward the "leaning" votes.

It's been suggested that our dinner program could be enlivened during the eating period if use were made of the large projection screen which, later in the program, will be used to carry the closed circuit TV exchange between the Los Angeles and San Francisco dinners. Telegrams, perhaps accompanied by pix of senders, could be flashed on the screen -- messages of tribute to Eisenhower primarily, with a paragraph endorsing Nixon's campaign added.

We would need at least fifty of these to be effective during the period reserved for eating. Duplicates could be shown in Los Angeles during the same period.

## IT'S VOTING TIME

### Candidate For Governor

What has Governor Brown who is seeking another term as Governor done for the veterans of the State of California? This is a very important question as it affects you and your dependents.

Legislatively, the Brown program has seen these accomplishments:

A liberalized educational assistance program for veterans and their dependents.

An updating and liberalization of tax exemptions for veterans with some major parts still to be voted on by the people.

Inclusion of disabled veterans in the Cal-Vet Farm & Home Life Insurance coverage.

Assurance that Cal-Vet benefits will go to California Veterans of Japanese ancestry who were removed from the state during the 1942 evacuation and went into service from another state.

On the administrative side, the Brown administration has carried on the "People Orientation" policy with considerable savings in both taxpayer and veteran, as well as expanded benefit to veterans.

Success was particularly notable in the Farm and Home Purchase Division, which underwent an immediate streamlining when Governor Brown took office in 1959, enabling this self-supporting function to maintain its low interest rate service to veterans. It also enabled Farm and Home Purchase offices to eliminate an irksome three year backlog of 18,000 applications for loans and to maintain all applications on a current basis.

A major stride was made within Farm and Home in the field of insurance when negotiations to provide additional insurance benefits under the Home Protection Plan were completed. Settlements were broadened so that in addition to paying the loan balance, the veteran's widow received an amount equal to 20 per cent of the loan balance in cash. In addition, the benefits would be doubled in the event of accidental death before age 70.

A new fire and hazard insurance contract was entered into with a single company which provides broadest coverage at rates lower than any other company or group of companies which offer on lesser coverage. (This coverage was said to be unobtainable!) The savings to veterans has amounted to a million dollars per year, and the coverage on their homes is both broader and more realistic.

In all, the Farm and Home Purchase division finds itself both efficient and solvent, with 160 million dollars worth of bonds still unsold.

The Governor's office, in the meantime, has thrown its full weight behind the 1960 and 1962 Cal-Vet Bond Issues as a means of continuing this worthwhile project.

At the Veterans Home, waiting time for entry has been cut from three years to ten months, while adoption of 18 recommendations for better operation of the home has resulted in greater efficiency, economic savings and comfort for the veteran members.

A modern, new medical treatment center and hospital addition has been added to the Home to furnish up-to-date medical service for the veteran members.

Governor Brown also approved construction of a new fireproof concrete grandstand for the Veterans Home baseball park. This replaces an old and unsafe structure that has been used in years past.

In January, 1960, a Claims and Rights Service was instituted to represent California veterans in claims primarily before the Federal Government. Immediate success of the effort brought installation of offices in San Francisco and Los Angeles. Resulting savings to the State amount to approximately \$400,000 per year.

### EDITORIAL

We want our readers to know that we contacted the Nixon for Governor headquarters here in San Francisco to obtain a story by Mr. Nixon voicing his personal opinion as to his ideas in reference to Veterans affairs in California and if he was elected Governor, what new legislation, if any, would be sponsored that would be beneficial to the veterans of California.

We advised the Nixon for Governor headquarters in San Francisco that we had received a story from Governor Brown and Mr. Shull, Republican running against Mr. Nixon in the primary.

We advised Nixon's headquarters that we wanted to be impartial politically in our editorial policy and there would be no charge for the space allotted to Mr. Nixon to tell his story.

All this was discussed with the Nixon for Governor headquarters in San Francisco some three weeks before the deadline. They were advised that the deadline for this copy would be May 4th.

They in turn advised us that this matter would be taken up with the Hixson & Jorgenson (public relations firm) in Los Angeles, who was handling Mr. Nixon's campaign.

We wrote an Airmail Special Delivery letter to the Los Angeles headquarters stating we would like to run a story by Mr. Nixon on Veterans affairs in California.

Not only did we fail to receive a story from the Los Angeles headquarters, but we are still waiting for even an acknowledgment of our letter.

We again contacted the SAN FRANCISCO HEADQUARTERS advising them that we have not as yet received Mr. Nixon's story. They informed us that they would check with the main Nixon headquarters in Los Angeles and see that we received the story by May 4th, the deadline.

May 4th arrived and still no story. We did receive a phone call Friday, May 4th, from someone indicating he was associated with the Los Angeles headquarters and assured us that if we would delay the deadline to Monday, May 7th, Mr. Nixon's story would be in our office Monday morning.

At this present writing we still have not received Mr. Nixon's story.

We certainly do not blame Mr. Nixon for this negligence. It is very possible he was not advised we were seeking a story from him as to his stand on California Veterans affairs. Or was he? We just can't believe that Mr. Nixon, a Veteran himself, and a very active member in Veterans' organization affairs, felt that the 2,300,000 Veterans in California were not important enough to him in being elected or defeated. **WE WILL SEE!**

### Voices of the Airways

Kansas City, Mo. (Special) — Long recognized by the Veterans of Foreign Wars as a man of many talents, Senior Vice Commander-in-Chief Byron Gentry has once again broadened the scope of his total accomplishments. An April 6, "Voices of the Airways" a book of poetry by Byron Gentry, was published by the Naylor Company of San Antonio, Texas.

Presently serving as prosecuting attorney for the City of Pasadena, Calif., and a former star of the National Football League, Gentry has written poetry as a hobby for many years. So impressed were the publishers, they had this to say about Gentry's works: "Unafraid to express his deep self, daring to attack problems most modern writers shun, the author brings freshness and vitality to the American poet that has long been lacking."

## Records\*

## EDUCATION

### *Driver Training Expansion*

Support the expansion and improvement of driver training programs in California's high schools with a view to training 100% of the eligible students, and promote the concept of driver training education as it relates to the general public. Consider making driver training mandatory before issuing drivers' licenses.

### *Teacher Training*

Require all candidates for standard teaching credential in elementary education to complete a course in safety education. Require secondary schools to employ fully credentialed teachers with adequate instruction in safety education, driver education and driver training.

## ENGINEERING

### *Uniformity of Signs, Signals, Pavement Markings —State, County and City*

Encourage officials of state, county and city government to adopt uniform recommendations regarding signs, signals and pavement markings as recommended in the Uniform Vehicle Code.

## *Communication on Freeways*

Experiment with telephone, radio or other means of communication on freeways for use of drivers having vehicular or other difficulties in transit.

## LAWS and ORDINANCES

### *Uniform Vehicle Code\**

Enact legislation bringing all sections of the California Vehicle Code up to the standards set by the National Committee on Uniform Traffic Laws and Ordinances as stated in the Uniform Vehicle Code — and, through Governor Edmund G. Brown and the Conference leadership, urge President John F. Kennedy to call a conference of all the governors of the 50 states for the purpose of stimulating the adoption of the Uniform Code.

### *Seat Belts\**

Promote legislation making it compulsory to install seat belts in all private motor vehicles.

### *Drivers' Licenses—Qualifications\**

Enact legislation providing that no driver shall be licensed before the age of 18 unless he has completed, when such is available, a full program of driver education and driver training which meets the nationally recommended minimums. Make provisions for more thorough examination of driver license applicants, including the use of psycho-physical tests, etc. Increase license fees, if necessary, to provide these additional facilities. Employ more actual driving demonstrations in license testing.

### *Accident Reporting\**

Make mandatory the reporting to the DMV of all accidents (presently only convictions, injury accidents, and property damage accidents of over \$100 are reported), in the hope that problem drivers can be helped before injury or death occurs.

## MOTOR VEHICLE ADMINISTRATION

### *Budget*

Study current needs of the Department of Motor Vehicles in all phases of its operation, with emphasis on increasing facilities for reporting, driver improvement programming, etc., and raise department budget to meet existing demands.

### *Research Projects*

Carry out additional research in: (1) single vehicle accidents; (2) psycho-physical problems of drivers; (3) driver vision; (4) driver attitudes; (5) vehicle design. Encourage county and state medical associations to aid in such studies.

### *Driver's Record*

### *Available to Courts*

Make available to traffic court judges all information regarding violator's prior driving record, including A.L.I. accidents as well as violations. Information to be used in fixing sentence only after a finding of "guilty."

## POLICE TRAFFIC SUPERVISION

### *Manpower and Training*

Strengthen police agencies in manpower and through increasing of salaries to recommended levels. Upgrade, through administrative action and citizen support, all areas of police training for traffic law enforcement, with particular emphasis on command training in police traffic supervision.

### *Aircraft for Traffic Control*

Continue and expand use of aircraft for enforcement and direction of traffic as another means of accident prevention.

## ORGANIZED CITIZEN SUPPORT

### *Safety Councils*

Give increased emphasis to the need for whole-hearted support in establishing new citizen support safety councils, both city and county-wide, and in strengthening those now in existence. Officials, business and industrial leaders should exert every effort to establish safety councils in all areas not presently served by such a council, and to see that these citizen organizations are financed and equipped to properly carry out their functions in matters of public education and traffic accident prevention.

## TRAFFIC ACCIDENT RECORDS

### *Uniform Reporting*

Require all enforcement agencies to adopt a uniform method of accident reporting as outlined in the Annual Inventory of Traffic Safety Activities. Encourage use of accident records in development of sound accident prevention measures.

## TRAFFIC COURTS

### *American Bar Assn.*

### *Traffic Court Program*

Continue support of the Annual Western Regional Court Conferences in cooperation with the American Bar Association's Traffic Court Program. Increase the number of conferences throughout the state toward the end that more court officials receive training in the nature of the traffic problem, accident prevention, accident investigation, scientific enforcement, uniform rules of sentencing, uniform bail schedules and the teaching of traffic safety from the bench.

### *Juveniles in Traffic Court*

Re-evaluate the juvenile justice code and the problems of the juvenile traffic law violator, with particular consideration being given to trying juvenile traffic violators in the traffic court as recommended by the American Bar Association.





First, let me correct my home address for you, since the Robert Haldeman to whom you addressed your letter is another individual who also lives in the Pacific Palisades and who is at present, as you can imagine, receiving a great deal of my mail.

My home address is 550 Spoleto Drive, Santa Monica, Calif.

We did, indeed, enjoy an unusual evening at the Jonathan Club and I certainly appreciated John's making possible our chatting again after many years. I certainly understand your reasoning regarding the timing of Bill Knowland's help and am very much aware of the situation regarding the "Right to Work" issue.

We, of course, recognize some potential problems with the forthcoming book, as you outline, but I think it will also have some counterbalancing advantages in the California Campaign. Some of these would include the reaffirmation of Dick's position and long record of leadership in the fight against Communism; the detailed clarification of the 1952 Fund Case -- which should help to counteract some of the current phony smears --; and a number of details regarding the 1960 Campaign which are pertinent in the forthcoming California election.

In any event, the commitments and contracts on this book were made prior to Dick's declaration for Governor and, in view of this and the amount of money involved, it would seem at this point to be unwise to hold it up.

We certainly enjoyed an unusual evening together as John Vaughn's guests at the Jonathan Club. There were high lights and low levels but on the whole a most memorable occasion. I particularly enjoyed our brief conversations including the few minutes we had together in the lounge late in the evening.

It occurred to me this morning as I drove home and considered our remarks that I should like to expand a little in better explanation of hastily expressed opinions. My thought that Bill Knowland could be more helpful in the primary rather than in the general election campaign was based on the fact that four years ago he was identified actively with the "Right to Work" issue on the ballot. This brought him into disrepute not only with labor but with quite a few of the liberal elements of the Democratic Party. As Dick Nixon will find it necessary to pick up the independent vote and some of the more liberal Democrats before he can expect to be elected, I then assume that Bill Knowland would be a burden in the latter part of the two campaigns.

As to the primary effort, if the two can be separated, Knowland does appeal to most of the conservative Republicans which of course, is more than a majority of the sentiment to select the nominee.


Also, I wanted you to know I am really a little concerned about the book to be released in serial form and later bound covers on the subject of the six Crises. Each of these will emphasize Dick Nixon's interest in affairs other than in California. It will be well and enthusiastically received nationally but in my opinion, not of real value to him in his campaign to become Governor of California. It also can be used by his opponent Pat Brown to point out his complete divorce from California developments during the past few years.

If on the other hand, Dick could prepare another book or series of articles on such a subject as "California, the Growth State during the 60's" he then could show his interest and constructive program on such subjects as agriculture, water and flood control, education including the Master Plan as an economy and efficiency development, more industry, more jobs rather than more relief and more unemployment insurance, an aggressive attack on highway congestion, etc.

It is necessary for me to repeat to you that I have a feeling of obligation to Knight based on my appreciation of the appointment as a member of the Board of Regents which prevents me from openly supporting any opposing candidate. You, however, have discovered my real sentiment which I hope I will be able to express openly either through the withdrawal of Knight or his defeat in the primary. This of course, is a confidential statement to you as a friend.

You have my best wishes for a successful effort. It will be a difficult task to elect Dick Nixon Governor and a more difficult one for him to get along with a Democratic Legislature. It can be done, however, but you must anticipate that Brown will become stronger between now and November and that no stone can be left unturned to acquire the necessary bipartisan support.



JAP BURCH called for RN and talked with rmw:

He said: "There are some things out here that are very alarming and I wonder if he really realizes what has taken place in recent weeks or months. It is almost shocking. I am at this time really afraid that Dick won't get anyplace if this thing continues. It is from the ground level. I am not much out of La Habra - what I hear is not good at all. For instance, we have this man Shell who came out to the ladies federation - at the Country Club and had quite a large crowd. He had spoken at that time before 360 groups of people. I was not at that meeting. I know several who were for Nixon who were at the meeting and they are not for Nixon now. I think RN has to pay more attention to this threat -- it is not anything to be brushed off as not being serious. "

"I do know that this one place made quite an effect. I am telling you now that if it is as effective in other places as it is now I think RN is in trouble."

rmw asked him if the people gave any reason for being for Shell or switching from Nixon to Shell.

His answer was: "I talked to quite a few Nixon supporters who are going to support Shell. Walter Knott who I know quite well is against him now. I will do anything I can to help. The people are hungry for someone to come out and tell them what to do. If RN doesn't soon get going I think that thousands will be committed before he gets started."
