Interestingly enough, I also have a letter from a Mr. John W. Davis, President of Imperial Industries, who compiled a file of his own on this subject which included memoranda over the signature of Mr. J. R. Glade.

This certainly could be a target. Any additional material you are able to pull in would be appreciated.

This sort of thing is turned over to our Research Department for study, correlation and incorporation into speeches, releases and attack statements. The data which you have sent is being passed along to them today.
