

In response to your letter of June 25th, I think you do not understand the law about political contributions. A corporation cannot contribute and, if they did, both the corporation would be subject to fine and the officers could go to jail.

My personal contributions, plus the contributions of many of our other officers, substantially exceed any billings that will be made to the Nixon-for-Governor Campaign;

There is no alternative but for us to charge the Campaign Committee with the gas and oil used when our plane is used, but you can rest assured that in the forthcoming campaign, the contributions of our executives will far exceed the cost of the plane and our company cannot make the plane available without charge without being subject to serious penalties.






Dear Mr. Haldeman:
