Dear Alice:

Thanks for the run-down on Eisenhower appointees and their present activities. I do not have the list from which you are working, and would very much like to have a copy.

I am aware of the complaint which we still seem to be getting regarding the length of time which elapses between a request to speak and acknowledgment of the letter.

However, we are proceeding, in effect, along the lines which you have suggested; a form letter goes out upon receipt of the request, saying that it is being referred to the Schedule Committee and that the writer will be hearing directly from them in the near future.

If you have specific instances of this complaint, please let me know so that we can check it through. Without this, it is difficult to ascertain where the system is not working.

Dear Joe:

The thought RN had on where Phil Ray could help was in the overall area of defense contracts to depressed areas.

As you know, this whole problem of awarding contracts on the basis of unemployment and other local problems rather than on the basis of ability to produce efficiently could become a major California issue. RN thought Ray's experience as head of the Committee that looked into that situation might be helpful. I think he and Cap should get together and discuss this.

Many thanks for your note of February 23 inquiring about how the Kuchel luncheon game out and what the situation is regarding my participation in his campaign.


I declined the invitation to luncheon. I have declined to serve on the finance committee but I have agreed to raise a modest amount of funds.
